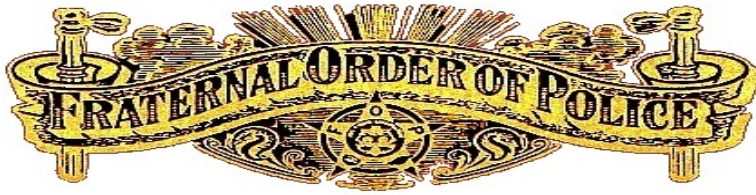
**MEMBERSHIP OATH**

  3. If only one Beneficiary in a class survives, we will pay the total death benefits to that Beneficiary.
